The Journal of Malaysian and Comparative Law (JMCL) welcomes original, unpublished works on topics of legal interest in the form of articles, comments, casenotes and reviews.

Manuscript will be reviewed by the Editorial Board before approval for publication. All manuscripts will be blind-reviewed. Contributors will be notified of acceptance, rejection or the need for revision of their respective manuscripts. The Editors retain the right to make stylistic and grammatical changes to manuscripts accepted for publication without necessarily informing the contributor.

### PREPARATION OF MANUSCRIPTS

(1) Manuscripts should not have been published, submitted, or accepted for publication elsewhere. Only original contributions are considered for publication.

(2) Manuscripts should be typed on A4 paper, double-spaced with generous margins on all sides of the paper. Two copies of the manuscript should be furnished and, wherever possible, accompanied by a diskette of the manuscript.

(3) Endnotes should be numbered consecutively from 1 to 99 and typed double-spaced on separate sheets at the end.

(4) Final responsibility for the accuracy of all citations and quotations rests with the contributors.

(5) Paragraphs start flush left after headings but otherwise are indented.

(6) Quotations of more than 30 words should be indented without marks. Shorter quotations within the text should be enclosed by single inverted commas.

## NOTES TO CONTRIBUTORS

(7) The following should be in italics:

- (i) Case names except the letter "v"
- (ii) Latin and other foreign words
- (iii) Abbreviations - *eg, ie, ibid, cf.*
- (iv) Titles of books and law journals/periodicals

(8) References:

The full title and date and place of publication should be given at first mention, thereafter *supra* should be used.

  - 3) CMLR
  - 4) All E R

Abbreviations are capitalised and not italised. Omit full stops from abbreviations.

- Law Journals
- 1) *Harvard Law Journal*
  - 2) *LQR*
  - 3) *U Chi L Rev*

Names of law journals/periodicals are italised. Omit full stops from abbreviations.

Title of Articles : P Balan, "Damages for Personal Injuries and the Civil Law (Amendment) Act 1984" [1989] *JMCL* 181.

Title of Books : V Sinnadurai, *Law of Contracts in Malaysia and Singapore: Cases and Commentary*, 2nd ed (Butterworths, 1987) pp 111-120

(9) The title page should include the contributor's name in full, designation, institutional affiliation, address and telephone/fax numbers.

(10) The above guidelines are not exhaustive. Contributors are kindly requested to refer to past issues of the JMCL for other style guides.
